AUDIT SUMMARY

Results in brief

In the areas we audited, Council operations complied with applicable requirements and provided adequate safeguarding of public resources. The Council also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the North Central Emergency Care Council from July 1, 2012 through June 30, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Council's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following area was examined during this audit period:

INFORMATION ABOUT THE COUNCIL

The North Central Emergency Care Council works with the Washington State Department of Health (DOH) and regional healthcare partners to ensure the continuation of the emergency medical services and trauma care system in north central Washington. It was established in 1991 and is governed by an 18-member Board of Directors composed of local representatives from law enforcement, health districts, communication/dispatch districts, DOH consultants, tribal officials, hospital representatives, local government representatives and others. The Board of Directors is appointed by the DOH.
