AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Grant County Fire Protection District No. 10 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Employee leave
- Surplus property

• Public works projects – small works rosters

INFORMATION ABOUT THE DISTRICT

Grant County Fire Protection District No. 10 was formed in 1958 to provide fire prevention and suppression services to residents living within its service boundaries. In 1964 the District began providing ambulance services. The District has one part-time Secretary, two full-time employees and 37 volunteer firefighters and emergency medical services personnel.

An elected, three-member Board of Commissioners governs the District. Total revenue was approximately \$429,000, \$565,000 and \$577,000 in 2011, 2012 and 2013, respectively.
