## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Kitsap County Sewer District No. 7 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE DISTRICT

Kitsap County Sewer District No. 7 is located on Bainbridge Island and provides sewer service to approximately 500 customers. The District has no employees and contracts for a District Manager, Engineer and Treatment Plant Operator. The District's sewage treatment plant for the Fort Ward area of Bainbridge Island also provides services to communities outside the District through an interlocal agreement.

The District had annual revenues of approximately \$331,000, \$464,000 and \$378,000 in 2011, 2012 and 2013, respectively. Three elected Commissioners govern the District.
