AUDIT SUMMARY

Results in brief

In the areas we audited, Cooperative operations complied with applicable requirements and provided adequate safeguarding of public resources. The Cooperative also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the WSIPC from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Cooperative's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

INFORMATION ABOUT THE COOPERATIVE

Washington School Information Processing Cooperative (WSIPC) is a cooperative formed by the nine educational service districts to provide extensive information system services to local school districts, district information service centers and other educational service districts. The nine educational service districts each appoint a board member to serve on the Cooperative's Board of Directors. The Cooperative develops, licenses and maintains software as well as provides technical support and network management. The Cooperative serves over 1 million students and 300 public/private school districts. In fiscal year 2014, the Cooperative had operating expenses of \$19,354,512.
