AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the City. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Town of Krupp from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE CITY

The Town of Krupp, incorporated in 1911, serves approximately 35 Grant County citizens. An elected, five-member Council and an independently elected Mayor govern the Town. The Town has one part-time employee and receives approximately \$14,711 in revenue each year.
