AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Mukilteo Water and Wastewater District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

INFORMATION ABOUT THE DISTRICT

The Mukilteo Water District and Olympus Terrace Sewer District merged on November 27, 2007, and changed the entity's name to Mukilteo Water and Wastewater District in 2008. The District provides water and wastewater services to approximately 28,000 residents in Snohomish County.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 21 employees. For fiscal years 2012 and 2013, the District operated on average budgets of approximately \$10 million for each year.
