AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated January 13, 2015, related to procurement and petty cash. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Snohomish County Fire Protection District No. 26 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• General disbursements

• Petty cash

INFORMATION ABOUT THE DISTRICT

Snohomish County Fire Protection District No. 26 provides fire prevention, suppression and emergency medical services to approximately 7,000 citizens. The District's service area covers a 36 square-mile area that includes the city of Gold Bar. The District partners with King County Fire Protection District No. 50 and provides an advanced life support response capability for the upper Skykomish Valley communities. Forty-eight volunteers respond to the nearly 1,000 calls annually for this upper Skykomish Valley community.

A five-member Board of Commissioners governs the District. A Board-appointed Fire Chief oversees the District's operations and its one full-time and 37 part-time employees. For fiscal years 2011, 2012 and 2013, the District had operating revenue of approximately \$1,149,943, \$1,259,323, and \$1,445,921.
