AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Grays Harbor County Fire Protection District No. 10 from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

Formed in 1964, Grays Harbor County Fire Protection District No. 10 provides fire prevention and suppression services, emergency medical aid and protection of life and property to residents living within its service boundaries. The District's service area covers 70 square miles along the Wishkah and East Hoquiam roads.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as a Secretary and approximately 14 volunteer firefighters. The District collected \$224,800 and \$220,550 in fiscal years 2012 and 2013, respectively.
