#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Pierce County Fire Protection District No. 10 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Contracts/agreements
- Open public meeting minutes

- Payments/expenditures
- Petty cash
- Financial condition

#### **INFORMATION ABOUT THE DISTRICT**

Pierce County voters established Pierce County Fire Protection District No. 10 in 1948. The District provides fire protection and emergency medical services to approximately 5,500 people in northern Pierce County. Fire protection service is provided by city of Tacoma firefighters under contract with the District.

The District is governed by an elected, three-member Board of Commissioners and has one employee. The District has an annual operating budget of approximately \$3.8 million.
