AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Peshastin Irrigation District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll/leave accrual
- Payments/expenditures

• Conflict of interest/ethics laws

INFORMATION ABOUT THE DISTRICT

The Peshastin Irrigation District provides water to orchards and fields within its boundaries in Chelan County. The District's main source of water is the Icicle River. An elected, three-member Board of Commissioners governs the District. The Board appoints a District Manager to oversee the daily operations as well as its five employees. The District operated on annual budgets of approximately \$330,000 and \$340,000 for 2012 and 2013, respectively.

The majority of the District's revenue is derived from water assessments based on the annual rate set by the Board and receives services provided from Icicle Irrigation District. The agreement with Icicle Irrigation District changed in 2011 to become more of a partnership.
