AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Spokane County Fire Protection District No. 5 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

Spokane County Fire Protection District No. 5, incorporated in 1948, provides fire protection and emergency medical services to approximately 2,000 residents covering 90 square miles in Spokane County. The District is bordered by Spokane County Fire Protection District Nos. 3, 9 and 10, Stevens County Fire Protection District No. 1 and Lincoln County Fire Protection District No. 4. Mutual aid agreements allow the District the opportunity to frequently receive and give assistance to these districts on major incidents. The District responds to approximately 80 calls each year out of two stations.

The District is governed by an elected, three-member Board of Commissioners. The Board appoints a Fire Chief to oversee the District's day-to-day operations and approximately 20 volunteers. It has one part-time employee. The District operates on annual operating revenues of approximately \$100,000, composed primarily of property taxes.
