## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the Ahtanum Irrigation District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE DISTRICT

The Ahtanum Irrigation District was established in 1918 to deliver irrigation water in the Ahtanum Valley in Yakima County. The District serves approximately 2,200 parcels of land.

An elected, three-member Board of Directors governs the District. The District employs one full-time Stream Patrolman and one regular part-time employee. Revenue for 2006 was approximately \$1,409,000 due to the last year of logging proceeds as well as a law suit settlement. In 2011 the District received approximately \$83,000 in revenue, of which \$44,000 was from member assessments.
