#### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated February 12, 2015, related to its annual report submission to the State Auditor's Office. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Okanogan County Fire Protection District No. 6 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

#### INFORMATION ABOUT THE DISTRICT

Okanogan County Fire Protection District No. 6 serves the Methow Valley area from Mazama to Carlton in Okanogan County. The District maintains four fire stations with a staff of three full-time station Chiefs, one full-time District Fire Chief and a part-time District Secretary.

The District is governed by an elected, three-member Board of Commissioners. The District receives most of its funding through property taxes. It collected \$976,941, \$715,772 and \$830,907 in annual revenue in 2011, 2012 and 2013, respectively. The County is the ex-officio Treasurer, which collects the District's revenue and is also responsible for investing the District's funds.
