## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of King County Fire Protection District No. 45 from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Controls over credit cards
- Controls over payroll

## INFORMATION ABOUT THE DISTRICT

King County Fire Protection District No. 45 was created in 1959 and currently serves the city of Duvall and surrounding areas. The District's service area covers approximately 56 square miles. The District maintains three fire stations. One station is staffed by career firefighters 24 hours a day, one station is staffed by volunteers and one station is used as a training center.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 19 employees and 22 volunteers. For 2012 and 2013, the District operated on annual budgets of approximately \$3 million, each year.
