## AUDIT SUMMARY

### Results in brief

In the areas we audited, Board operations complied with applicable requirements and provided adequate safeguarding of public resources. The Board also complied with state laws and regulations and its own policies in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Adams County Water Conservancy Board from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Board's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE BOARD

The Adams County Water Conservancy Board was established in 1999 to provide local processing of water right transfer applications and records of decision for Adams County. The Board is governed by a three-member Board of Commissioners appointed by the County. The Board's funding comes primarily from application fees. The District receives revenues of approximately \$2,000 per year.
