## AUDIT SUMMARY

### Results in brief

In most areas we audited, Commission operations complied with applicable requirements and provided adequate safeguarding of public resources. The Commission also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Commission management in a letter dated March 11, 2015, related to contract monitoring. We appreciate the Commission's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the Washington State Mint Commission from July 1, 2013 through June 30, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Commission's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contract and agreements
- Research project compliance

## INFORMATION ABOUT THE COMMISSION

The Washington State Mint Commission was established in 1981 by state law to coordinate marketing of mint and to increase production efficiency of mint produced in the state of Washington. It is funded primarily by assessments on the mint growers and gatherers. The Commission is governed by an eight-member Board of Commissioners composed of members representing mint growers and gatherers.
