## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Zillah Transportation Benefit District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Cash receipting
- Safeguarding of small and attractive assets such as computers
- Conflict of interest
- Payments/expenditures
- Open public meeting minutes
- Payroll/personnel

## INFORMATION ABOUT THE DISTRICT

The Zillah Transportation Benefit District was established by state law (RCW 36.73) in November 2011 to assist in the financing of transportation improvements in the city of Zillah. An elected, five-member Board of Directors governs the District. The District assesses a \$20 vehicle license fee as its only source of revenue. The District collected approximately \$13,000 and \$39,000 in 2012 and 2013, respectively.
