## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Whatcom County Water District No. 2 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Billing, adjustments and receipting
- Cash management
- Payroll/accounts payable

## INFORMATION ABOUT THE DISTRICT

Whatcom County Water District No. 2 was established in 1945 and provides water services in the Marine Drive area along Bellingham Bay on the northwest side of Bellingham. Revenue is derived mainly from water sales with total receipts of \$436,622 in 2013 and \$472,741 in 2014. The District has two employees and is governed by an elected, three-member Board of Commissioners.
