AUDIT SUMMARY

Results in brief

In most areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to Authority management in a letter dated March 31, 2015, related to insufficient tracking of grant expenditures. We appreciate the Authority's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Twisp Public Development Authority from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Cash receipting

• Grants and donations

INFORMATION ABOUT THE AUTHORITY

The Twisp Public Development Authority was created in 2008 by the Town of Twisp. Its purpose is to facilitate the acquisition, ownership, redevelopment, improvement, management and maintenance of property located within the town, including but not limited to the property, as well as other redevelopment projects as the Twisp Town Council deemed necessary.

The Authority is governed by an appointed, five-member Board of Directors. For fiscal years 2011, 2012, and 2013 the Authority operated on annual budgets of approximately \$331,000, \$374,000, and \$328,000, respectively.
