## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Snohomish County Fire Protection District No. 27 from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE DISTRICT

Snohomish County Fire Protection District No. 27 is a volunteer organization dedicated to providing medical and fire emergency response services to the Gedney and Hat Island communities near Everett. An elected, three-member Board of Commissioners governs the District. In 2012 and 2013 the District received approximately \$87,020 and \$78,626, respectively in annual revenue.
