AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Mukilteo School District No. 6 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement systems review
- Sno-Isle Skills Center
- Financial condition

- Disbursement systems review
- Overtime payments

INFORMATION ABOUT THE DISTRICT

Mukilteo School District No. 6 provides public school services to approximately 15,000 students in preschool through the 12th grade in Snohomish County. The District's service area covers 26 square miles including parts of the cities of Everett and Mukilteo.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 950 certificated and 700 classified employees. For fiscal year 2014, the District expended approximately \$170 million.
