AUDIT SUMMARY

Results in brief

In the areas we audited, Pool operations complied with applicable requirements and provided adequate safeguarding of public resources. The Pool also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Schools Insurance Association of Washington from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Pool's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following area was examined during this audit period:

INFORMATION ABOUT THE POOL

The Schools Insurance Association of Washington was formed through an interlocal agreement among seven founding school districts in 1995. The interlocal agreement allows the joint purchase of insurance, joint self-insuring, joint hiring or contracting for risk management services and claims administration. As of the end of fiscal year 2014, there were 42 member districts in the Pool.

The Pool is regulated by the state Office of Risk Mangement with the Department of Enterprise Services. An elected, eight-member Board of Directors governs the Pool's activities. The Pool contracts with a private firm for claims administration and risk management services and does not have any employees. For the year under audit, the Pool operated on annual budget of approximately \$28 million.
