AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Lake Chelan Sewer District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

The Lake Chelan Sewer District was established during the 1950's to provide sewer services to the Lake Chelan area in Chelan County. The District serves approximately 265 customers.

An elected, three-member Board of Commissioners governs the District. The District has no employees of its own and uses the city of Chelan for the general operation and maintenance of its facilities. For 2012 and 2013, the District received annual revenue of \$246,473 and \$337,721, respectively.
