## AUDIT SUMMARY

### Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Town of Harrah from January 1, 2010 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Safeguarding of small and attractive assets
- Open public meeting minutes
- Payments/expenditures
- Open public records laws compliance
- Payroll/personnel

## INFORMATION ABOUT THE TOWN

The Town of Harrah is located in Yakima County and has a population of 630 residents. The Town operates under a mayor-council form of government with an elected Mayor and five-member Council. The Town has two full and one part-time employee who provide water, sewer and irrigation services.

The Town contracts with the Yakima County Sheriff's Office for law enforcement. Fire protection is provided through Yakima County Fire Protection District No. 5 and volunteer firefighters. The Town operates on an annual budget of approximately \$400,000.
