## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of La Conner School District No. 311 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student enrollment reporting
- Financial condition
- Advance travel imprest fund

- Open Public Meetings Act
- Financial reporting requirements

## INFORMATION ABOUT THE DISTRICT

La Conner School District No. 311 provides educational services to approximately 625 students in kindergarten through 12th grade in Skagit County. The District operates one high school, one middle school and one elementary school.

An elected, five-member Board of Directors governs the District. The District has approximately 106 employees including a Superintendent who oversees the District's daily operations. The District operated on an annual budget of \$9.1 million during fiscal year 2014.
