AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Ellensburg School District No. 401 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting District office and community schools
- Payroll
- Associated student body high school
- General disbursements
- Credit cards
- Information technology assets

INFORMATION ABOUT THE DISTRICT

Ellensburg School District No. 401 provides educational services to approximately 2,810 students in kindergarten through 12th grade in Kittitas County. Services include basic elementary, middle school, high school, vocational, bilingual, Running Start and special education. The District also provides pupil transportation, food services and numerous programs for remedial and enriched education.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's operations as well as its 186 certificated and 102 classified employees. The District operates on a \$28 million annual budget.
