## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Adna School District No. 226 from September 1, 2011 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- General revenues and expenditures
- Procurement – public works
- Credit cards
- Associated Student Body
- Cash receipting
- Payroll
- Financial condition

## INFORMATION ABOUT THE DISTRICT

Adna School District No. 226 provides educational services to approximately 606 students in Lewis County. The District has one combined middle and high school and one elementary school.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee the District's day-to-day operations as well as its 66 employees. For the fiscal years 2012, 2013 and 2014 the District operated on annual budgets of \$5,491,660, \$5,610,064 and \$5,565,944, respectively.
