## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Tenino School District No. 402 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General revenue and expenditures
- Open Public Meetings Act
- Financial condition
- Significant internal control systems:
  - Cash receipting
  - Lunch receipting
- Learning Assistance Program
- Small and attractive assets
- Enrollment reporting
- Staff mix reporting
- State grants
- Associated Student Body

## INFORMATION ABOUT THE DISTRICT

Tenino School District No. 402 provides public school services to approximately 1,180 students in kindergarten through 12th grade in Thurston County. The District has approximately 156 full- and part-time employees who provide instructional support, special education, food, maintenance, janitorial, office and nursing services.

An elected, five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee the District's day-to-day operations and to carry out decisions made by the Board. The District operated on budgets of \$12.4 million and \$13.2 million in fiscal years 2013 and 2014, respectively.
