## AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Napavine School District No. 14 from September 1, 2011 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Revenue/expenditures trend
- Enrollment
- Staff mix
- Financial condition

- Internal controls over:
  - Cash receipting
  - Disbursements
  - Payroll
- Procurement public works

## **INFORMATION ABOUT THE DISTRICT**

Napavine School District No. 14 provides public school services to approximately 783 students in kindergarten through 12th grade in Lewis County. The District has 46 certificated and 49 classified employees who provide instructional support and Special Education instructional support as well as food, maintenance, janitorial, transportation, office and nursing services.

An elected, five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee day-to-day operation and carry out the decisions made by the Board. For fiscal years 2012, 2013 and 2014, the District operated on annual budgets of \$7,396,261, \$7,741,357 and \$7,969,002, respectively.
