### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Oak Harbor School District No. 201 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student enrollment reporting
- Alternative Learning Experience
- Associated Student Body
- Third party cash receipting

- Teacher education and experience (staff mix) reporting
- Open Public Meetings Act

### **RELATED REPORTS**

#### **Financial**

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements.

### Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report. That report includes a federal finding regarding inadequate internal controls and non-compliance with time and effort requirements.

### Other reports

We have conducted a separate audit to examine the District's compliance with Alternative Learning Experience (ALE) requirements. ### INFORMATION ABOUT THE DISTRICT

Oak Harbor School District No. 201 is located in Island County and provides public education services to approximately 5,500 students from kindergarten through 12th grade. The District is the largest school district in Island County with a 60 square-mile service area, which includes the city of Oak Harbor, Naval Air Station Whidbey Island and the northern part of Whidbey Island.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 664 employees. For fiscal year 2014, the District operated on an annual budget of \$53 million.
