AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Colfax School District No. 300 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevaling wage)
- Interlocal agreements
- Teacher education and experience (staff mix) reporting

INFORMATION ABOUT THE DISTRICT

Colfax School District No. 300 provides public school services to approximately 600 students from kindergarten through 12th grade in Whitman County. The District operates one elementary school and one junior/high school. The District's elected, five-member Board of Directors are the primary policy-making body, exercising budgetary and financial control for the District.

The District has approximately 90 employees who provide students basic education and support services. The Superintendent and Business Manager administer day-to-day operations of the District and carry out decisions made by the Board. The District operated on annual budgets of approximately \$7 million for each of the 2013 and 2014 school years.
