AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated May 7, 2015, related to financial condition. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of San Juan Island School District No. 149 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Open Public Meetings Act

• Financial condition

• Disbursements

• Cash receipting

• Payroll

INFORMATION ABOUT THE DISTRICT

San Juan Island School District No. 149 provides educational services to approximately 750 students in kindergarten through 12th grade on San Juan Island. The District includes Stuart Island School serving kindergarten through eighth grade, when necessary. There were no students enrolled at Stuart Island during the 2013-2014 school year.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 190 employees (including substitutes). For fiscal years 2013 and 2014, the District had a general fund budget of approximately \$8.8 million and \$9.1 million, respectively.
