## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Northwest Educational Service District No. 189 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Procurement
- Program revenues
- Third party cash receipting
- Safeguarding and surplus of assets
- Open Public Meetings Act

## INFORMATION ABOUT THE DISTRICT

Northwest Educational Service District No. 189 provides educational support services to 35 school districts and several private schools located in Whatcom, Skagit, Island, San Juan and Snohomish counties. The District provides administrative, technical and instructional support services and programs, as well as cooperative programs. The District also acts as a liaison between the schools and the Office of the Superintendent of Public Instruction. The majority of the District's funding comes from fees for cooperative programs and grants.

The District is governed by a nine-member Board of Directors. The Board appoints a Superintendent who is responsible for the District's daily operations as well as its approximately 235 employees. The District's operating budgets were \$19.7 and \$21 million for fiscal years 2013 and 2014, respectively.
