AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Royal School District No. 160 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following area was examined during this audit period:

INFORMATION ABOUT THE DISTRICT

Royal School District No. 160 serves approximately 1,550 students from kindergarten through 12th grade in Grant County. The District operates one high school, one middle school and one elementary school and has approximately 203 full- and part-time certificated and classified employees.

An elected, five-member Board of Directors governs the District. For fiscal year 2013 and 2014, the District operated on a budget of approximately \$15.9 million and \$17.8 million, respectively.
