AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Zillah School District No. 205 from September 1, 2011 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public records laws compliance
- General disbursements/expenditures
- Associated Student Body fundraisers and expenditures
- Teacher education and experience (staff mix) reporting
- Student enrollment reporting

INFORMATION ABOUT THE DISTRICT

Zillah School District No. 205 provides a full range of school programs and services to approximately 1,300 students in kindergarten through 12th grade in Yakima County. These services include basic elementary, intermediate school, middle school, high school, vocational education, bilingual education, pupil transportation, food services, special education and numerous special programs for remedial and enriched education.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its certificated and classified employees. For fiscal years 2012, 2013 and 2014, the District operated on annual budgets of \$12.1 million, \$12.7 million and \$13 million, respectively.
