#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of College Place School District No. 250 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement public works
- Procurement purchases
- Procurement professional services
- Teacher education and experience (staff mix) reporting
- Student enrollment reporting
- Payroll

#### **INFORMATION ABOUT THE DISTRICT**

College Place School District No. 250 provides a full range of school programs and services including elementary, middle school, bilingual education, special education, student counseling, pupil transportation and food services. The District operates three schools and serves approximately 750 students in Walla Walla County.

A five-member Board of Directors, elected to four-year terms by District voters, governs operations. The Board appoints a Superintendent who is responsible for the day-to-day operations. The District employs approximately 95 staff members. The District operated on a budget of \$14 million for fiscal year 2013 and \$39 million for fiscal year 2014.
