AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Ephrata School District No. 165 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student enrollment reporting
- General disbursements

INFORMATION ABOUT THE DISTRICT

Ephrata School District No. 165, established in 1902, provides basic and supplementary education programs. The District serves approximately 2,350 students and has six schools including two elementary schools, one middle school, one junior high, one high school and one alternative school. The District has an agreement with several area school districts to provide special services for the deaf. In addition, the District provides support services including breakfast and lunch programs and Associated Student Body and transportation services.

An elected, five-member Board of Directors governs the District. A Board-appointed Superintendent oversees day-to-day operations. The District operates on an annual budget of approximately \$24 million.
