## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Warden School District No. 146-161 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Teacher education and experience (staff mix) reporting
- Student enrollment reporting

### INFORMATION ABOUT THE DISTRICT

Warden School District No. 146-161 provides public school services to students in kindergarten through 12th grade in Grant County. The District serves approximately 930 students. The District has one elementary school building. Its middle school and high school share another building. The District provides basic and supplementary education programs and services for hearing impaired, handicapped, special education and special education pre-school students. In addition, the District provides breakfast and lunch programs and Associated Student Body and transportation services.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's day-to-day operations as well as its 130 full- and part-time employees. The District operates on an annual budget of approximately \$10 million.
