AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Camas from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utilities
- Fire Department
- Procurement public works and architectural and engineering services
- Payroll disbursements
- General disbursements
- Financial condition
- Open public meeting minutes

INFORMATION ABOUT THE CITY

The City of Camas serves over 20,880 citizens in Clark County. It is administered by a mayorcouncil form of government. The City has seven elected Council Members and an independently elected Mayor. The Council appoints a City Administrator to manage the City's day-to-day operations as well as its approximately 176 employees.

During 2014, the City operated on an annual budget of approximately \$66.8 million. The City provides services including police, fire protection, ambulance, streets, sanitation, recycling, storm water, recreation, library, public improvements, planning and zoning, water supply treatment and distribution, sewage collection and treatment and refuse collection. In addition, the City operates a cemetery.
