### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Tacoma School District No. 10 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Billings/receivables
- Cash receipting
- Debt
- Fundraising
- Open public meeting minutes
- Procurement (bidding/prevailing wage)
- Payroll/personnel

- Teacher education and experience (staff mix) reporting
- Associated Student Body
- Conflict of interest
- Payments/expenditures
- Compliance with grant requirements
- Use of restricted funds
- Information technology/data security

## INFORMATION ABOUT THE DISTRICT

Tacoma School District No. 10 is located in Pierce County and is the third largest school district in the state. The District operates five comprehensive high schools, six alternative learning sites, nine middle schools and 35 elementary schools. The District provides educational services to approximately 27,500 students from preschool through 12th grade.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 3,500 employees. For fiscal year 2014, the District operated on an annual general fund budget of \$343,610,753 and an Associated Student Body fund budget of \$4,325,941.
