AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Republic School District No. 309 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body receipting
- Staff mix

INFORMATION ABOUT THE DISTRICT

Republic School District No. 309 is located 120 miles northwest of Spokane in Ferry County. The District serves approximately 300 students in three buildings, including an elementary school serving kindergarten through sixth grade students, a middle school serving seventh and eighth grade students and a high school serving ninth through 12th grade students.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. A Board appointed Superintendent oversees the District's daily operations as well as its approximately 60 employees. The District's annual budget is approximately \$4.1 million.
