## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Fife School District No. 417 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Cash receipting
- Safeguarding of small and attractive assets such as computers
- Debt/covenants
- Open public meeting minutes

- Teacher education and experience (staff mix) reporting
- Associated Student Body
- Legal authority for official actions taken
- Payments/expenditures

## INFORMATION ABOUT THE DISTRICT

Fife School District No. 417, located in Pierce County, provides educational services to approximately 3,468 students during school year 2013-2014 and 3,496 students during school year 2012-2013. The District has one high school, one junior high school, one middle school and three grade schools.

An elected, five-member Board of Directors governs the District. The District has approximately 224 certificated and 124 classified employees. The Superintendent is appointed by the Board and is responsible for the day-to-day operations of the District. The District operated on annual general fund budgets of approximately \$34,778,921 for school year 2013-2014 and \$32,515,719 for school year 2012-2013.
