### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated May 2015, related to weaknesses in ASB controls that increase the risk of funds being misappropriated. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Tukwila School District No. 406 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevailing wage)
- Financial condition
- Third party receipting

- Student enrollment reporting
- Associated student body
- Bank accounts

## INFORMATION ABOUT THE DISTRICT

The Tukwila School District, located in King County, serves approximately 2,900 students from preschool through the 12th grade. The District operates one high school, one middle school and three elementary schools.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 380 employees. For fiscal year 2014, the District operated on an annual general fund budget of approximately \$34.5 million.
