AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated June 23, 2015, related to fuel card and fuel pump controls. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Lakewood from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third party cash receipting
- Financial condition
- Police Department
- Payroll/personnel
- South Sound Military and Community Partnership
- Fuel card/pump processes
- Payroll/personnel
- Credit cards and accounts
- Procurement – public works
- Procurement – purchases
- Small and attractive assets

INFORMATION ABOUT THE CITY

The City of Lakewood was incorporated in February 1996 and currently serves approximately 58,360 citizens in Pierce County. An elected, seven-member Council governs the City. The Council elects one of its members to serve as Mayor. The City Manager is appointed by the Council and is responsible for the day-to-day operations of the City. In fiscal year 2014, the City operated on budgeted revenue of \$76.5 million.

The City's 240 employees provide a range of services including police, public works, planning and permits and certain parks and recreation services. The City contracts with public and private entities for many of its services including fire protection, certain other parks and recreation services, emergency medical services, public utilities, public transportation, street maintenance and library services.
