AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Metropolitan Park District of Tacoma from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting – other decentralized locations
- Cash receipting, disbursements and inventory controls at Boathouse Marina

INFORMATION ABOUT THE DISTRICT

The Metropolitan Park District of Tacoma was created in 1907, by a vote of the people, to operate parks and recreation facilities. Its boundaries include the city of Tacoma and areas of Browns Point and Dash Point. The District currently administers numerous sites, including Point Defiance Park, Seymour Conservatory, Tacoma Nature Center, Point Defiance Zoo and Aquarium, Northwest Trek Wildlife Park, Fort Nisqually, Boathouse, Meadow Park Golf Course and many neighborhood parks.

An elected, five-member Board of Commissioners governs the District. Commissioners serve staggered, six-year terms. The Board appoints an Executive Director to oversee the District's daily operations as well as its 250 full- and 800 part-time or seasonal employees. The District's two-year, 2013-2014 operating budget for the general fund totaled \$45.5 million.
