## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Spokane County Fire Protection District No. 10 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll/personnel
- Payments/expenditures
- Procurement (prevailing wage)

## INFORMATION ABOUT THE DISTRICT

Spokane County Fire Protection District No. 10 provides fire protection and emergency medical services to approximately 6,400 residents within an approximately 100 square-mile area surrounding the city of Airway Heights and Fairchild Air Force Base.

An elected, three-member Board of Commissioners governs the District. It has five fire stations, nine full-time employees and approximately 85 volunteer firefighters. In 2013 and 2014, the District had operating expenditures of \$1.7 million and \$1.8 million, respectively.
