## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated June 25, 2015, related to cash receipting weaknesses at high school Associated Student Body concessions. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Yakima School District No. 7 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body activity –  
Eisenhower High School and Wilson  
Middle School
- Payments/disbursements
- Third party cash receipting
- Payroll

## INFORMATION ABOUT THE DISTRICT

Yakima School District No. 7 operates 24 schools to provide educational services to approximately 15,400 students in Yakima County. Services include basic elementary, middle school, high school, vocational education, vocational skills center, alternative schools, bilingual education, pupil transportation, food services, magnet schools, special education and remedial and enriched education programs. In addition, the District provides transportation vehicle repair services.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its 1,750 full- and part-time employees. The District operates on an annual budget of approximately \$220 million.
