AUDIT SUMMARY

Results in brief

In the areas we audited, Corporation operations complied with applicable requirements and provided adequate safeguarding of public resources. The Corporation also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Kennewick Economic Development Corporation from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Corporation's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Accounting/financial reporting

• Revenue and expense review

INFORMATION ABOUT THE CORPORATION

The City of Kennewick Established the Economic Development Corporation in August 1982, under the provisions of Title 39, Chapter 84 of the Revised Code of Washington. The Corporation was established for the purposes of facilitating local economic development and employment opportunities through the financing of industrial development facilities using nonrecourse revenue.

The Corporation has a five-member board appointed by the City. All obligations of the Corporation are paid by user fees and are fiscally dependent upon the city as all bond issues must be approved by the City of Kennewick. There was no activity in 2014.
