## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Agency operations complied with applicable requirements and provided adequate safeguarding of public resources. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Lewis Mason Thurston Area Agency on Aging from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- General revenues and expenditures
- Internal controls over cash receipting and general disbursements

- Payroll
- Provider contracts
- State grants
- Small and attractive assets
- Financial condition

## INFORMATION ABOUT THE AGENCY

The Lewis Mason Thurston Area Agency on Aging seeks to assist in the development of a comprehensive and coordinated service system for senior citizens who live in Lewis, Mason and Thurston counties. Its major functions include funding, coordinating, planning, providing direct services and advocating.

The Agency operates on a \$6.5 million annual budget with approximately 54 employees. A majority of its revenue comes through state and federal grants. The Agency is responsible to the federal Department of Health and Human Services, Administration for Community Living and the Washington State Department of Social and Health Services, Aging and Long Term Support Administration, which oversee the Area Plan.

Locally, the Agency is governed by a Council of Governments created by Lewis, Mason and Thurston counties. A Council-appointed Director oversees day-to-day operations.
