### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Department operations complied with applicable requirements and provided adequate safeguarding of public resources. The Department also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Department of Revenue from July 1, 2013 through June 30, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Department's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Marijuana tax revenue (I-502)
- Cash receipting

#### RELATED REPORTS

#### **Financial**

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

#### Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

#### Performance audits

Initiative 900, approved by voters in 2005, gives the State Auditor's Office the authority to conduct independent performance audits of state and local government entities. Performance audits may include objective analysis on ways to improve program performance and operations, reduce costs and identify best practices.

### INFORMATION ABOUT THE DEPARTMENT

The Department of Revenue's mission is to fairly and efficiently collect revenue and administer programs to fund public services and advocate sound tax policy.

The Department is Washington's principal tax collection agency, overseeing more than 60 different taxes and collecting the majority of state general fund tax revenue. In fiscal year 2014, the Department collected \$19.6 billion in state and local taxes and processed more than 2.2 million tax returns from 525,000 registered businesses. The Department also manages the state's Unclaimed Property Program and processes business license applications and renewals. The Department strives to provide the highest level of customer-focused service to taxpayers to ensure voluntary compliance with state tax laws.

For the period under audit, the Department had an annual operating budget of \$122 million. The Department's staff of 1,147 includes a wide variety of professionals such as auditors, analysts, appraisers, foresters, programmers, lawyers and support staff. The Department is headquartered in Olympia with 12 public offices throughout the state and 50 auditors in out-of state locations.
